2. Is there a need for a Measure to make collaboration commonplace in the education system, to improve school governance and to simplify the planning of school places in Wales?

Wales has an impossible dual medium education system where Welsh medium schools are allowed to come into existence at will and parents allowed to choose these schools from out of catchment area. The result is that the number of schools grows and WM schools become smaller on average whilst the larger EM schools are closed or amalgamated. Average size of a WM secondary school is 743 pupils and an Em secondary is 974. At primary level the difference is greater. Despite this, advantageous funding of WM schools results in better teacher pupil ratios (15to one WM 16.7to one EM). Freedom to choose a WM school has resulted in marked socio-economic stratification. 10.87% of pupils in WM schools are on Free School Meals in EM schools it is 20.08%. 85.3% of WM GCSE pupils are in schools with less than 15% on FSMs. 43.5% of EM GCSE pupils are in schools with less than 15% on FSMs Socio economic stratification is most marked in places like Cardiff where the WM secondary schools have the lowest number of Ethnic minority pupils (6% against an average 23% for EM schools) and amongst the lowest percentage on FSMs. Nevertheless these schools are given an extra £98,000 a year so that they can have pupil teacher ratios of 14 to one! Since 2007 the performance gap between pupils on FSMs and Non FSMs has widened from 28.8 to 31.3. This under a socialist government! The Assembly are ideologically mired and devoid of the will to Educate the poorest in society whilst pouring money into the lap of Middle class Welsh speaking parents. A disgrace.
