Data included in response to WQ88547, WQ88730, WQ88911, WQ88912 and WQ88913 refers to undergraduate students who started courses following the reforms to student support policy in 2018. We have not included postgraduate expenditure since this is a contribution to costs, provided direct to the student, and cannot be broken down into maintenance and tuition fee loans.
